As per condition 8(2) on March 31, 2029 & at a intervals of five (5) years thereafter, the company shall submit a re-evaluation of the amount of Financial Assurance.

Re: Financial Assurance Evaluation – Stericycle Brampton Site

As required by condition 8(2) of ECA A680324, please find below our evaluation of the amount of financial assurance required under condition 8(1). The re-evaluation includes an assessment based on any new information relating to the environmental conditions of the Site.

## **Assumptions:**

- Maximum allowable amount of waste on site: 250 m. tonnes
- The waste stored on site is as follows:
  - o 36 m. tonnes (3 bins) of incinerator ashes
  - o 214 m. tonnes of untreated waste (all types)
- All the untreated waste will be disposed of by incineration. This disposal method is acceptable for all waste types and also represents the most costly disposal alternative.
- Anatomical biomedical waste storage is limited to the volume (weight) that can physically be stored within the on-site refrigeration unit

• Incinerator ashes (36 m. tones) are sent to Emerald Energy for final disposal (Waste to Energy Incineration)
